The communities on this list have been identified as having good signage management, based on review of their codes of ordinances and/or observation of their territory. Generally, this means that a business may have one reasonable-sized freestanding sign and reasonable wall signs, but no tall off-premise advertising signs (usually called billboards) are allowed and no large changeable message signs (such as electronic billboards) are allowed. (Non-conforming signs may exist, depending on the date of enactment of the sign ordinance.)
